## Police detain four-month-old-baby, mother over electrocuted apprentice It was learnt that the base of the police Station of the pol

Policemen attached to the Igbogbo Police Station, Ikorodu, Lagos State have been accused of detaining a fourmonth-old-baby and his mother over a man killed by electrocution.

It was gathered that the police detained the child and his mother, identified as Idiat Ajisebutu, 24, a hairdresser after she went to the station to report that a welder died from electrocution in her shop.

The family of the hairdresser claimed that the police held Idiat and her baby for days.

Idiat's husband, Segun Ajisebutu, narrated how his wife and baby were

detained. He told Sunday Vanguard, "I received a call from my wife, on Monday, April 4, that someone came to reconnect electricity supply in her hairdressing shop but the man was electrocuted in the process. She told me that one Emmanuel, a welder, who also has a shop in the area, ordered that electricity supply to her shop be disconnected because she was owing N2,000 bill. She told me that she later paid N1,000 and Emmanuel told his apprentice, one

Chris, that he

should go to my wife's shop to reconnect. The apprentice, Chris, was reconnecting the electricity when he was electrocuted. My wife raised the alarm and people in the area ran to her shop and saw Chris dead. She was advised to report the electrocution to the police and she went to the Igbogbo Police Station, Ikorodu and reported the unfortunate incident. The police took her statement and went ahead to detain her with our four-month-old baby boy. The police kept my wife and our child in the cell for five days. On Saturday, April 9, they were transferred to the State Criminal Investigations Department, Panti, Yaba, where she is still being held

over Chris death". Ajisebutu alleged that the police



at the SCID manhandled his wife and efforts to get her bail had proved abortive as the family of the deceased was demanding N2million as compensation for its dead kinsmen.

"While my wife was still being

held at the Igbogbo Police Station, the family of Chris came to the station and demanded N2million as compensation for the victim so that they could drop the case. My wife told them that she did not have that kind of money. That was how the police at Igbogbo transferred the case to the Homicide Unit, SCID, Panti, Yaba. The police at Igbogbo Division handed her over to officers at the Homicide Unit, Panti, to be detained in their cell, but when the officers on duty tried to take her baby from her, she wept that she should be released as she had nothing to do with the electrocution", the husband

'Moreover, she was the person who reported the electrocution to the police. As she was pleading and holding on to her child, the policemen started beating her. They slapped her and forcefully collected her baby and handed him over to my sister in-law to take the baby home".
