3 2 brothers kill 62-yr-old retired vice principal in Ondo

A KURE—A 62-year-old retired Vice Principal, Chief Joseph Omosuyi, has been reportedly punched to death in Okitipupa area of

Ondo State by two brothers over argument on family land.

Detectives have subsequently picked up the two brothers, Sunday and Gbenga Akinye.

Vanguard gathered that the incident occurred at Agirifor

area in <u>Ilu-Titun town</u>, Okitipupa council area of the state.

The suspects, who are being detained at the Criminal Investigation Department CID of the state Police Command, reportedly dealt some blows on

the community leader when his submission on a piece of land belonging to their family did not go down well with them.

A source said that there had been some disagreement in the community over the piece of land that the family of the suspects have been claiming its ownership.

Vanguard learned that the matter had been pending for over a year because those who intervened could not resolve it amicably to the satisfaction of the feuding families.

The community leader was reportedly approach to help mediate in the unresolved family land matter but his judgement reportedly infuriated the brothers, who descended on him.

He was said to have been punched during the meeting and the deceased reportedly slumped and died before he could get to the hospital for medical attention.

Timely intervention of Policemen in the community saved the situation from becoming bloody as youths and children of the deceased attempted to lynch the suspects.

Contacted the Police spokesman, Femi Joseph, who confirmed the ugly incident said that investigations on the matter

Joseph told Vanguard that the suspects are in their custody "I don't know the extent of their involvement but at present, those are the two suspects we have in our custody over the incident, but we are still investigating."

## I didn't intend to kill my father —DAUGHTER

A LADY, who allegedly killed her father over suspicion that he was responsible for the deaths of her five children, two husbands and mother, said she had no intention of killing him but was provoked into taking the action.

The 31-year- old Glory Bassey, currently in the custody of the Akwa-Ibom State Police command, Vanguard learned overburdened by her wordly challenges she went before her late methor's gravette scale.

confronted the dad with the allegation of witchcraft, which the father refuted, but not without a dispute that led to the death of the 75 yeas old father, Chief. Bassey Daniel Udo.

But the suspect, who hails from Mbiakpan Atan Village, Ibiono Ibom Local Government Area of Akwa-Ibom State, said "Evening after the dream, I went to my father and confronted him with these revelations and after some arguments, he brought out a stick and beat me with it.

"Provoked by that beating, coupled with how I was already

feeling about him, I seized the stick from him and hit him in return. People in the neighbourhood rushed to intervene and I went back to my house and there was nothing wrong with my father when I left. I am surprised that the next day, I was told he died.

Speaking on the matter, the Akwa-Ibom State Police Public Relations Officer, PPRO, Delia Nwawe, said the case was reported by the Village Head of Mbiakpan Atan, Ibiono Ibom Local Government Area, Chief Linus Effiong Okon, against the suspect who is also, the daughter of the deceased.
