# Again, hoodlums attack INEC offices in Enugu, Owerri, Awka

SUKKA—BARELY six hours after hoodlums attacked Anambra State Headquarters of the Inde-pendent National Electoral Commission, INEC, in Awka and set it ablaze with an explosive device, midnight fire suspected to be set by arsonists has razed another. Independent National Electoral Commission's, INEC, head-quarters at Igbo-Eze South Local Government Area of Enuou State.

It was gathered that the suspects who stormed the premis-es of the INEC at about 12 am, scaled the perimeter fence before torching the facility. Personnel of the Neighbourhood Watch group in the council area who were alerted by the incident, rushed to the scene and saved the fa-cility from being totally de-

Meantime, Ebonyi State Police Command, yesterday said it had arrested the kingpin behind the co-ordinated attacks on three Police Divisional Headquarters in Onicha, Abaomege and Ohao-zara Local Government Areas of the state.

Confirming the Enugu attack on INEC, the Chief Press Secretary to the local government chairman in Igboeze south, Nkem Ossai said: "It is true that the INEC headquarters in Igbo-Eze South Local Government Area of Enugu State was torched by unknown hoodlums. However, it was not totally burnt down. Only one room was burnt and personnel of the Neighbour-hood Watch in the council area were quick at securing the official documents in the office thereby preventing them from being burnt.

The watch personnel scaled the fence to put out the fire before the arrival of fire service workers from both Udenu, and Nsukka Local Government Areas. The hoodlums could not get access to the INEC facilities because the premises was locked.

"The suspected miscreants set the facility on fire around few minutes past 12 am on Monday morning and ran away. I can tell you that no casualty was recorded."

launched against the attackers on the spot by the combat-tle ready policemen recorded 95 percent success, which led to the recovery of arms and ammunition from the hood-

Owolabi who did not provide casualty figures as ac-cording to him, investigations were still in progress, however noted that none of his men lost his life during the encoun-

According to the CP, "I got a call around 8.15am that my B-division was under attack by armed hoodlums and there were lots of firing of guns and disturbance of public peace. My men there defended them-selves and resisted the hood-

serves and resisted the hood-lums very strongly.
"We all knew it was a ploy to attack INEC office. So, we proceeded to the office where we were able to engage the hoodlums and demobilized the three vehicles they came with which made them scamp-

er for safety."
Although unconfirmed reports said four of the attackers were gunned down, the Anambra State Commissioner of Police, Mr. Christopher Owolabi told reporters that the command had started combing hospitals in and around Awka for the wounded attackers who allegedly

fled with injuries.

The attack, which started at about 9pm on Sunday caused pandemonium in the Anambra State capital as sound of gunshots could be heard several kilometres away. Many people who were at a popular night club around the Ekwueme Square had to spend the night there as the fireworks could not allow them to drive home.

low them to drive home. According to Owolabi, the police recorded over 90 percent success in the battle against the attackers, adding that the hoodlums were forced to abandon three hilux vans

they came with. Owolabi said: 'The hoodlums first went to "B" division police station and were re-pelled. Then, they came to INEC and our men repelled them too.

"I can tell you that we recorded about 95 percent success. There were no casualties on the part of the police contrary to some media reports that scores of policemen were

Since last night, we have been moving from hospital to hospital because we are sure some of the attackers escaped with serious wounds and we are appealing to the manage ment of various hospitals to help us track them. Eight rif-fles, consisting of AK 47 and pump action, as well as live ammunition and items of clothing and berets were re-covered from the attackers."

While assuring the people of the state of safety, Owolabi urged them to be law abiding as they go about their normal businesses and to keep security agencies abreast of devel-opment around their areas. "We're working with all the armed forces: army, navy, civil defence, DSS and others in-cluding joint patrol. We're back in the street reclaiming the public space."

On his part, the INEC Resident Electoral Commission,
Dr. Nkwachukwu Orji disclosed that six of the office vehicles, collation centre and part of its store were affected

in the incident.
"The damage is not substantial because the police were able to contain them. The areas affected were the open space we use for our collation centre and part of our store. About six of our vehicles were affected. But we're still accessing the

level of damages".
Asked if the incident would affect the November 6 Anambra governorship election, the INEC chief simply replied: "conducting election is for the commission to decide".

#### Suspected arsonists torch INEC office in Imo

In a another development, suspected band of arsonists weekend, attacked the Inde-pendent National Electoral Commission's, INEC, office at Ahiazu Mbaise local govern-

ment area of Imo State.

Confirming the incident in a telephone chat yesterday, the Resident Electoral Commis-sioner, REC, Professor Emeka Ezeonu, said that the incident was a clear case of attempted

His words: "A spirited attempt was made weekend to burn the INEC office at Ahiazu Mbaise local government area of Imo State, I cannot explain why hoodlums are now targeting INEC offices.

"On getting wind of the ugly development, I sent a high powered delegation to go and assess the extent of the damage done to the facility. The report they sent in showed that it was a clear case of at-tempted arson, presumably in tempted arson, presumany in the early hours of Sunday, May 23, 2021. The hood-lums destroyed the external burglary proof and it appeared that when they realized that they still had to contend with another burglary proof inside the office, they onted to try their luck through opted to try their luck through the roof.

'They opened the roof and sent in their inflammable sub-stance and lit it. Part of the Conference Room was burnt, window protectors were de-stroyed and Almaco windows smashed. However, by sheer divine intervention, the early morning heavy rainstorm, ef-

fectively put out the fire."
While confirming that the matter has been reported to the Divisional Police Head-quarters in the local council area, the Resident Electoral Commissioner wondered why people are not speaking against the growing damag-es of public establishments in the South East.

## Ebonyi Police arrest mastermind of attacks on Police Divisions

According to the Police items such as firearms and ammunition including one Double Barrel English gun, with eleven live cartridges; one locally made single gun; one Riot Police smoke gun-ner stolen from Ohaozara Police Divisional Headquar-ters; three Police Bartons; one hand grenade, one canister of teargas, and two Police belts were recovered.

Other items included: two Police radio communication handsets with chargers; all stolen from Onicha Divisional Headquarters which was also attacked and set ablaze on 4th Feb. 2021: four Biafra flags and one juju box.

In a statement by the Com-mand's Public Relations Officer, PPRO, DSP Loveth Odah: On the 20/05/2021, at about 1700hrs following the intelligence report of movement of arms and ammunition and the report of armed robbers terrorizing Isu, Onicha LGA, one Eluu Ekpehu Emmanuel was arrested who made useful statement to the Police and led Police operatives to the house of their gang leader popularly known as "Blood";

"There were his cohorts who are alleged to have been who are alleged to have been terrorizing the area and the master minders of the various attacks on three Police Divisional Headquarters in the area, namely Onicha, Abaomege and Ohaozara.

"Blood and his cohorts on "Blood and his cohorts on sighting the Police, opened fire on the operatives who gallantly fought back. In the process, Blood was apprehended with gunshot injuries while others escaped into the nearby bush with bullet wounds. Blood's house and premises were immediately searched and items were re-

"The wounded suspect was immediately rushed to AE-Federal Teaching Hospital (AE-FETHA) Abakaliki for medical treatment where he later gave up the ghost. The corpse was deposited at the same hospital mortuary for preservation. The gang is responsible for the attacks on vernment facilities and the killing of security agents in

dering self-service for the state. He made the disclosure at has country home, Aguleri, has country home, Aguleri, hambra East Local Government Area of Anambra State shortly after inspecting the Anambra Literature of the Anamarka Literature of the Anama ambra International Passen-ger and Cargo Airport at Umueri.

The governor who also described himself as "a man of classical quality," said the air-

port was built with the best of facilities as can be obtained in any international airport of re-

Earlier during the inspection, the state Commissioner for Works, Engr. Marcel Ifejiofor, who conducted the governor

who conducted the governor and his entourage round the airport facilities said the international airport is Class 4F which can take any aircraft. He also said 'The orientation is that the aeroplane can land at either side of the runway. That was what happened on April 30th, 2021, when we did the test flight, one landed on 024 and the other one landed on 06. This airport has two Runway Air Safety Areas, RASA. This is the only airport in Nigeria with this type of in Nigeria with this type of RASA. It has category two light which means that the airplane

can land at the worst of any weather in this airport. "It also has satellite facili-ties which means that if the light is not working, aircraft can land with the satellite fa-cilities. So with what we have on this airport it would be on this airport, it would be difficult to have a cancelled

It is the only airport in Nifits the only dipolit in Ne-geria with this type of satel-lite facilities. This is the only airport in Nigeria that is cur-rent with the Friction Test. Before the airplane landed on the 30th, we carried out the test and got 0.79 which is the highest so far in this country. The height of the Control Tower is 34.5." The Commissioner who

said that work on the airport would be completed in no distance time, assured that passengers who would use the airport would have the best of

air travel experience.
While lauding the governor for the legacy project, the chairman of Nsukka Journal-ists Foundation, NJF, Chijioke Amu-Nnadi, who led a team of journalists from Nsukka extraction in Enugu State to the airport during the inspection, said the project will guarantee slow but steady re-ordering of the economy of the South East Region. Amu-Nnadi also described

the governor as a visionary leader who has left an enviable legacy as the governor of Anambra State. He commended him for the cordial working relationship between him and his Chief Press Secretary, James Eze, who is also a member of NJF.
