# Many injured, commuters stranded as transporters protest alleged extortion by task force, LASTMA

AGOS-Commercial activities Liwere disrupted for the better part of vesterday at Cele, Ivana-Isolo and Toyota bus stops on the Oshodi/Apapa expressway and on the Mile-Two Badagry expressway, following protest by transporters over alleged extortion and high handedness by officials of the Lagos State Environmental and Special Offences Unit (Task Force) and Lagos State Traffic Management Authority, LASTMA.

The protesters took over the busy sways, displaying placards and set up bonfires on the expressway inward Oshodi, preventing commercial motorcyclists and tricycle operators from conveying passengers

Their colleagues, who were oblivious of the protests, had their windscreens shattered, with passengers ordered to alight from the vehicles.

They chanted "No more task force," displaying placards with inscriptions such as "End LASTMA brutality", "End Task Force wahala", "End LASTMA blocking, blocking with Task Force", "End Task Force in Lagos State."

Their grievances
They alleged that Task Force officials routinely and indiscriminately seized their vehicles and were forced to pay huge amount before they would releas

A bus driver, who gave his name as Sefiu, alleged that LASTMA officials impounded two of his vehicles without any justification.

He said: "I paid N55,000 to recover one of them. They are always harassing us. The road we ply to the airport has been blocked for repairs, yet when we take alternative routes they will claim

it is one-way and they'll arrest us."

Another protester, who identified himself simply as Kingsley, said: "Their wahala is too much. We want Governor Babajide (Sanwo-Olu) to help us.

Chibuike, who identified himself as a bus driver and member of the National Union of Road Transport Workers, NURTW, also accused the officials of extortion. He urged the state government to intervene.

On his part, Mukaila, who claimed he recently paid N22,500 to get his bus back, said: "If we argue with them, they would beat us up and tear-gas us. We are tired. Do they want us to start stealing and be carrying guns? We are tired of their extortion, and constant

Another driver, Opeyemi, said he was also protesting because a vehicle he got on hire purchase barely two months ago was impounded by the Task Force

He said: "I paid N250,000 to get the vehicle back on Monday

### 3 commercial drivers killed

Opeyemi also alleged that three

commercial drivers were killed on sundayatthe Cele Busstop.
At the Cele bus stop, a commercial bus driver and a commercial motorcyclist sustained deep cuts in the

The protesters.

Hoodlums, who hijacked the situation, attacked anyone at sight. They dispossessed helpless commuters of cash, telephones, handbags and other valuables

At the scene, shattered windscreen: littered the ground while the stranded commuters were seen running away from the hoodlums.

A similar protest occurred last week at Iyana-Oba, Idimu, Igando, down to Iyana Ipaja.

### 16 suspects arrested

Meanwhile, the Lagos State Environmental and Special Offences Unit (Task Force), said it had arrested 16 miscreants suspected to have masterminded the violence and attack on commuters in Cele and Iyana Isolo

The miscreants, according to a statement by the task force, capitalised on the peaceful no work protest embarked upon by drivers of commercial buses on Oshodi-Mile 12 Expressway to unleash mayhem on commuters.

The statement signed by its Head Public Affairs Unit, Mr Femi Moliki read: The hoodlums were caught molesting passers-by and destroying public facilities. Machetes, charms, cudgels and other harmful weapons were recovered from them.

The Chairman of the Lagos State Task Force, CSP Shola Jejeloye, who was in the area to maintain law and order as well as listen to some of the aggnieved protesters, called for calm that government would address their grievances.

"He added that no official of Lagos State Task Force operates between Toyota and Mile 2, adding that the agency is presently rejigging its operation to prevent reported incidences of illegal task force operatives in the metropolis.

"He said he had listened to all

complaints against the officials of the agency, noting that genuine complaints would be addressed.

"It was learned that the drivers decided to protest the installation of signage on roads that used to serve as bi-directional ways as One-way."

## 3 policemen, 13 others killed in Rivers, Kogi, Plateau

SIX persons, including a commercial motorcycle operator, were yesterday, killed by gunmen suspected to be cultists in Gwara and Kono-Boue communities, Khana Kono-Boue Communities, Khana Kono-Boue Communities, Khana Kono-Boue Communities, Khana Khana (Pivers State

ocal Government Area of Rivers State. It was gathered from a resident that the gunmen, numbering about seven, invaded the Gwara community, shooting indiscriminately, leaving three persons dead.

The resident disclosed that later in the day, the gunmen stormed neighbouring Kono-Boue where a motorcycle rider and the two persons he was carrying ran into them and were

The Public Relations Officer, Community Development
Community of Kono-Boue, Nwibakpo Golden, while narrating the incident, said some villagers ran into the bush and to safer areas to avoid being hit by

He said: "This afternoon, unknown unmen invaded Gwara community, killing about three persons. They later went to Kono-Boue, killing a motorcycle rider and the persons that were with him."

Asked if the security agencies were notified of the incident, Golden said he put a call across to the Divisional Police Officer in charge of Bori Division, saying heresponded but the hoodlums had taken flight.

He said the absence of a functional police station and the bad road in the rea had worsened the security situation there, saying villagers who fled were

yettoretum.

He said: 'The governor of Rivers State once promised that there will be a police station there. Kono-Boue is very large community. We are still hoping that he will fulfil his promise. "Second, the road there is bad. If they

fix the road, the police can easily access the area anytime we call them. The DPO came with his team, but the gunmen did not waste time. He (DPO) was able to restore normalcy.

When contacted, a spokesman of the state Police Command, Nnamdi Omoni, said he would get in touch with the DPO, Bon division and get back to our correspondent.

### Robbers kill 2 policemen at Kogi checkpoint

In a related development, two policemen were, Monday evening, killed by armed robbers at Kriga checkpoint along Kabba-Iyara road in

council area of Kogi State.

It was gathered that the policemen
were shotwhen they flagged down the
robbers' SUV coming from Ekiti axis and were probably heading towards Abuja en-route Kabba for a routine

Vanguard also gathered that three other policemen, who managed to escape, sustained injuries as the fleeing robbers shot sporadically to pave way for their escape.

It was learned that the affected policemen were from the newly created Kabba Police 'B' divisional headquarters.

The remains of the two policemen were said to have been deposited at the morgue of the general Hospital Kabba while the injured are said to be undergoing treatment at a private

hospital.
The Assistant Inspector-General of

Police, Zone 8. Ede Avuba, who confirmed the incident, said the police have since after the incident mobilised and are on the trail of the hoodlums

### 8 killed as security agents battle suspected gunrunners, kidnappers in Plateau

Also on Monday, a Police Inspector, one local vigilante and six suspected gun-nunners lost their lives when the gunmen engaged security agents in a gun battle at Bwai village, Pvem Chiefdom, Gindiri district, Mangu Local Government Area of Plateau

Uba, who confirmed the incident said: "On 23/08/2021 at about 1400hrs, the command received credible information about the activity of a notorious syndicate of gunrunners at Kwoi village, in Mangu LGA of the

On receipt of the information, the IGPs Intelligence Response Team (IRT) based in Mangu, Police operatives attached to Mangu Division, STF and local vigilante were mobilised and swiftly raced to the area.

On sighting the team, the hoodlums engaged them in a gun battle. But because of the tactical operational because of the factical operational capability and superior gunfire of the operatives, six of the hoodlums were neutralised while others fled with bullet wounds. Exhibits recovered from them include three AK-47 rifles with Breach Nos 868, 106076 and 123487.

"Regrettably, one Insp. Abdulrahaman Isah, who is the Comunander IGP's Intelligence Response Team based in Mangu and one Hassan Mohammed, a local vigilante gallantly paid the supreme price.
