Ex-BBNaija housemate, Rico Swavey, dies after auto crash • As fellow housemates mourn

AGOS FORMER Big Brother Naija housemates of Double Wahala' Season 3 were, yesterday, thrown into mourning, as they lost one of their own. Patrick Fakoya, popularly known as Rico Swavey to the cold hands of death.

Swavey, who was one of the 20 housemates during the Season 3 edition of the reality TV show, was involved in an auto crash last Tuesday in Lagos and had been on life support since then before his eventual demise

Another ex-housemate, Ifu-Ennada, described the deceased as "a great friend who was never envious of anybody. So many beautiful memories. He was a great friend to me and many others. Rico had the best songs and I loved them...I was always rooting for him and he rooted

"He'd call or text to check on me, my business and how I was doing. All he wanted was peace and progress. He was never envious, was always content and stayed optimistic... He was always so careful and attentive. Everything still feels like a

Swavey died hours after his managementannounced that he was on life support as his situation was critical and doctors were battling to save his life. But unfortunately, BBNaija star did not make it.

The deceased became famous after participating in the Season
3 'Double Wahala' edition of the Big Brother Naija reality tv show in 2018. The grand prize of N45 million was won by Miracle with Tobi emerging as the first runnerup followed by Alex and Nina.

Born in 1993, Rico Swaveywas a lawyer social media influencer, artiste and actor. The Law graduate of Babcock University was also into music until he got into the Big Brother Naija Season 3, "Double Wahala" house.
