Many feared dead as herdsmen invade Enugu community narratives.

•Gunmen set court ablaze in Imo, second incident in 24 hours •Suspected kidnappers shoot Ebonyi Assembly commission member dead in Anambra •Wanted gunman apprehended

SUSPECTED **FULANI** herdsmen collaborators from Agala community in Benue State yesterday, affacked Ebor community in Eha-Amufu, Isi-Uzo local government area of Enugu State.

A <u>yet-to-be-ascertained</u> number of people were killed during the latest attack

The attack at Eha-Amufu happened as the magistrate court in Owerri, capital of

Imo State was set ablaze by gunnen yesterday.

In a related development, a Commissioner, in Ebonyi State House of Assembly Commission, Leonard Chibuzor Alegu has been shot dead in Anambra by suspected kidnappers.

The incident, it was gathered occurred between 9 and 10 p.m. on Saturday al Umunya community in Oyi Local Government Area of Anambra State.

The deceased was allegedly travelling from Abakaliki to Onitsha to attend a child dedication in Onitsha when

the incident occurred.

Meantime, members of a local vigilante have arrested a notorious gunman, Chukwuma Ejionye, in Ezinifitte, Nnewi South Local Government Area of Anambra State. 'The native of Awo, Ezinifite in Nnewi South has been linked to different attacks in Ezinifitte and the entire Nnewi South.

Many feared dead in Enugu community

The attack in Eha-Amufu happened barely eight days

after assailants attacked the community and killed 25 people. The attack forced residents of Mgbuji, r<u>esidents</u> of Umujiovu, a: Umujiovu, and Ebor communities to flee their

Subsequently, businesses were forced to shut down in Eha-Amufu, the third-largest town in Enugu.

A security source lamented Sunday's attack and the negligence of the state government to tackle the problem once and for all.

The source said: "These assailants have sacked over 40.

villages and settlements. Now, they are attacking the hometowns. This is the charvesting period and people have been forced out of their homes and communities and the government is paying lip service to this. These people are coming from communities in Benue State and the government is aware

'The invaders outnumbered the soldiers and vigilantes, launched another attack on Ebor-community this Sunday morning. I have seen bodies of less than 10 but can't give a specific figure

right now.
"We are still in the bushes combing and searching for more people killed. What is happening here is unfortunate. It is exactly what they did to the Benue State people. Probably, they want to create a vast land joining Benue communities they had already sacked and call it their land.

"From the report I received, the armed herdsmen and their collaborators from Benue State communities launched the attack around 5:30 am to 6 am this morning. Before we got there, several people had been killed. We are few soldiers here and where

we are based is a little bit far from the communities. There operatives from other security agencies here in Eha-Amufu except local vigilantes. They (vigilantes) first engaged them but the invading armed herdsmen outnumbered them," the source added.

A community leader, who gave his name as Ogbuabor Samuel, confirmed the attack.

"As I am speaking to you, the invading armed herdsmen are still shooting. Several people have been killed. At least, we have recovered the bodies of have recovered the bodies of 10 people killed. The chairman of Isi-Uzo local government is playing politics with our lives. He didn't want to tell the governor the facts of what is happening in these communities. He is not supporting the local vigilantes and other local security.

"A few weeks ago, he dissolved all the local vigilantes formed by Eha-Amufu communities, yet he hardly visits the affected communities. We need the government to declare a state of emergency on security in Eha-Amufu, especially in Ebor, Umujiovu, Mgbuji, and Agu-Amede communities. Governor Ifeanyi Ugwuanyi should do something drastic. His government should stop politicizing the situation in our

They should stop fabricating stories that our people are collaborators. That is a fallacy and it diverts attention from and it diverts attention from the real issues. Agala people in Benue State have joined forces with armed Fulani herdsmen to continue to kill and destroy our people. That is the situation. Since these recent attacks started in October, we haven't seen policemen here. You can only see the police if their commissioner is coming to witness the destruction and go back to Enugu to dish out false "Where are the tactical squads and operational assets of the police he told Nigerians through the media that he had deployed."

"We want to know, who are the security agencies in Enugu State protecting their interest? Could it be that the security chiefs in Enugu State are in the state to give cover to armed herdsmen?"

It was earlier reported that in the last two years, starting from January 2021 till date, no the fewer than 120 people had been reportedly killed by criminals suspected to be Fulani herdsmen in Eha-himself when the staspected kidnappers accosted him and in the process of struggling to

The gunmen attack did not record any casualty. Michael Abattam, Imo Police Spokesperson, did not respond to calls or messages when contacted on the incident. The development came hours after a similar incident happened in Orlu on Saturday when the high court in Orlu LGA of Imo State was set ablaze by gunmen. KURE-THE 91-year-old ARetired Anglican Bishop of Akure Diocese, in Ondo State, Rev Emmanuel Bolanle
Gbonigi, weekend, adduced
reasons why the next
president must come from the
South East.
Gbonigi said in a statement

in Akure, the Ondo State capital, that he was adding his voice to "those who are convinced that our next president should come from the second control of the control of th the southeast political zone of

our country.
"My reason for this is more than political and human philosophy. It is because of divine will. The God who created heaven and earth has a number of attributes. The most important of the attributes are divinity, holiness, righteousness, justice, love,

mercy, peace and prosperity.
The most relevant of these attributes to the topic of where our next president should come from is justice. God is God

of justice.
"He wills or desires that everyone of the people He created should have his or her share of what He has given to

all His people.
"Therefore, God certainly
wills that every part of our
country Nigeria should have the joy of seeing one of them serving as President of our country.

"The one and only geopolitical area of our country that has not enjoyed this gift of God is the southeast geographical zone. The Yoruba ay it's the food shared by all in a party that's sweet: " ajoje ni undun". They also say you eat and I eat make the food palatable: "je ki unje n'dun". "Another Yoruba saying is that a well fed dog cannot play as a friend with a hungry one."

as a friend with a hungry one "Aja ti o yo kii ba eyi ti ko yo sere. So, we see that the Yorubas carry the will of God their Creator in their culture and tradition. I am sure that the other tribes or nations of

the other tribes or nations of Nigeria also do.

"I appeal to you my fellow Nigerians, whatever is your profession or occupation: teachers, farmers, civil servants, politicians or others to please reflect the attributes of God

"Politicians in particular must copy God's attribute of justise. God is the God of justice. He is just in all His relationship with human beings and God expects you as a politician to practice justice in all your relationships with other

people"
The clergyman said that: "
Justice is the prerogative of peace. It means that without justice, there can be no peace and without peace, there can

be no prosperity."

Gbonigi added: "So, let us practise justice in every facet of our political lives. The same is true in all other areas of our national life'
