Court remands Osun park mgt member in prison

Osogbo — A Federal High Court sitting in Osogbo, Osun State has ordered that a member of Osun Park Management Disciplinary Committee, Oyeyemi Olalekan, be remanded in prison custody.

Olalekan was arraigned, vesterday, on 11-count charge but his counsel, Edmund Biriomoni, challenged the jurisdiction of the court to entertain the case.

When the matter was called, Biriomoni objected that the defendant cannot be docked

the court lacked jurisdiction to take his pleas on some of the counts in the charge sheet.

The prosecutor Umar Alli. has earlier prayed the court to withdraw a charge dated October 16, 2023, before it and substitute it with a charge dated January 31, 2024, contending that objection can only be raised after the plea had been taken.

After the withdrawal and substitution of the charge, counsel to the defendant also withdrew the preliminary objection to the first charge.

Justice Ayoola, thereafter, ordered the remand of the defendant in Ile-Ife prison and directed his counsel to file his objection.

The court subsequently adjourned the case to March
