While condoling the family of the deceased and directing the arrest of the driver, he said that the vehicle has been recovered at the station as investigation is ongoing.

The Federal Road Safety Commission, FRSC, also said that one female child was killed, while six other people were injured in the road accident.

The Acting Sector Public Education Officer of the Anambra State Command of FRSC, Margaret Onabe, in a statement identified the driver of the Sienna bus with registration number NEN 588 YX, belonging to the Transport Company of Anambra State, TRACAS, as Eze Uchechukwu.

She said that the probable cause of the crash was brake failure, which made the vehicle to ram into the market.

She said: "At the time FRSC rescue team from RS5.3 Nteje arrived the scene, they were informed that the injured victims had been taken to Urban Hospital and Maternity for medical attention, while the dead victim was taken to the morque. The vehicle was taken by DTO team Oyeagu.

"The FRSC team visited the hospital where the victims were taken to for medical attention to ascertain the condition of the injured victims.
