Gunmen abduct ex-Reps member, kill Police escort in Nasarawa dastardly manner with the captive

●Kidnap 8-yr-old boy, 4 others, demand N15m ransom in Kogi ●Murder 67-yr-old cleric in Lagos

LAFIA—A former member of the House of Representative, Dr. Joseph Kiqbu, was reportedly abducted, yesterday, on his way to Jos.

This came as gunmen adopted five persons at two communities within Western senatorial district of

Kogi State.

In a related development, a pastor with Royal Assembly Sanctuary, Lagos, Apostle Ranti Ige-Daniel, has been killed by his abductors.

2 On the abduction of former reps member the bandits in a gun battle reportedly shot the Police escort attached to Joseph Kigbu while trying to resist the kidnappers.

It was gathered that when his vehicle was stopped along side other motorists, gunshots were fired sporadically by the bandits, leaving the Police orderly dead.

The kidnap took place about 6:00pm between Nunku, Akwanga Local government, Nasarawa State and Gwantu, Sanga local government, Kaduna State.

Residents of the villages around the spot said several criminal activities have taken place in that area in recent time.

Efforts to get the state police command police public relations officer's reaction were not successful at press time.

Aside the five persons kidnapped in the two communities of Kabba/ Bunu council area, four others were also reported to have been abducted in Isaniu, headquarters of Yagba East JGA of the state.

Vanguard gathered that two rothers, Chief Dare Olowosegun Obafanyo and Mr Bareke Job, were Ibducted on Monday, November 28, 1024 in broad day light.

Job, a former chairman of Rewire echnicians' Association in Kabbatunu and his brother were said to ave been adopted on their family and located in Aliqu in Kakun mmunity, a suburb of Kabba, eadquarters of the council area.

Also, Joshua Aiyegboka, Miss pe Aiyegboka and eight-year-old lorunmowaju Victory were inapped same day opposite the condary school in Odo-Ape at out 11:40pm.

The kidnappers have since ntacted their families for ransom

to be paid before they are released.

Job's brother, Jerome Bareke, who spoke on behalf of the family appealed to the state government and security agencies to help rescue their family members, who have been in the kidnappers' den for almost a week.

Jerome said the abductors initially demanded N15 million ransom but have reduced it to N10 million. Also, the kidnappers are demanding N50 million for the three victims abducted in Odo-Ape.

In a related development, a pastorwith Royal Assembly Sanctuary, Lagos, Apostle Ranti Ige-Daniel, has been killed by his abductors.

This was revealed by another cleric, Rev. Francis Kofoworola Iselowo of Faith Pavilion Inc, Arlington Texas, USA, on his Facebook wall @Rev.Dr. FrancisKFIselowo.

He said: "Apostle Daniel, based in Lagos wa<u>s taken away</u> by the wicked ones last Thursday, November 28, 2024 between Idofin and Makutu road near Isanlu, Kogi State, Nigeria.

"Your life was snatched in a

dastardly manner with three people still under the captivity of the kidnappers. You were going for a burial in Isanlu but not knowing that it will be your last day on earth.

"While writing this I heard that the kidnappers were asking for N10 million per person before they can

be released.

"You were a true son of Mopa. A kingdom of Christ builder. Going through your page on Facebook I could see where you were warning everyone that Jesus could come at anytime hence, we should all be prepared to face eternity. You have fought a good fight of faith like Apostle Paul. Your immediate family will miss you. Your church in Lagos will miss you. Mopa city will miss you. The body of Christ at large will miss you. Nigeria and the world will miss you.

Ondo Amotekun arrests security guard who staged his kidnap

AKURE —A security guard at a rubber plantation in Edo State, Sule Gende, has been arrested by the Ondo State security outfit, codenamed, Amotekun for organising his abduction and demanding N50m ransom from his employer.

Parading 22 suspected criminals in Akure, the state capital, the state commander of Amotekun, Chief Adetunji Adeleye, said two other suspects were arrested in connection with the crime.

Adeleye said the security guard, who organised his own abduction, was picked up at his duty post at the rubber plantation in Edo State and was taken to a hideout in the Southern senatorial district of Ondo State

He noted: "Rather than waste time on their prosecution in Ondo State and in the spirit of collaboration, we would release these two suspects to the office of the Director of State Services, DSS, of Edo State for them to conclude and complete the trial of those that were apprehended."

According to him, the security guard was lodged in an apartment owned by a 19-year-old friend, who is a security guard, for days before he was arrested by the security personnel.

The 19 year old suspect, James Lisbon, said he agreed to accommodate him because he was informed that he would be travelling to Benue State soon. Lisbon said that his friend augmented the visitor's feeding by giving him

N10,000 twice.

Also in an interview, an official of the company where the kidnap victim worked, said it was shown on CCTV that the night guard was kidnapped by gunmen.

He added that abductors later opened a line of communication with the company and demanded N50 million for his release. According to him, they later agreed to accept N35 million

million.

"They eventually said they could not get anything less than N15 million. The official added that the company informed the Department of State Security Services (DSS).

"But when there was no trace of the kidnappers, the company contacted Amotekum Corpsin Ondo State and this paid off as the two suspects were tracked to their hideout."

businessman, Elvis Okpaleke, has asked a Lagos High Court sitting in Eti-Osa area of the state to restrain a property owner, Dr. Edokpolo Austin, from evicting his company from its business premises at 15a, Admiralty Way, Lekki Phase 1, Lagos.

Joined in the suit as co-defendants are Cynthia Austin, Austin Family Holding Ltd, Uplift Medical Nigeria Ltd, Cignet Properties Ltd, Akorede Adeyinka and Stallion Technology Ltd.

Okpaleke trading under the business name of BLD Restaurant, averred that there is a deliberate attempt by the defendants to illegally evict his business from its present location despite the significant improvement he had made on the property infurtherance of his restaurant business

Heclaimed that without prior notice or being offered the right to buy the said property, the defendants has already taken steps such as disconnecting essential utilities on the property which interferes with his right to peaceful possession.

In an Interlocutory Injunction filed

along the suit, Okpaleke is asking the court to, among other prayers, grant an order of interlocutory injunction restraining the 1st to 7th defendants from interfering with his lawful possession of the business premises pending the full determination of the suit.
